Public Figure Law and Legal Definition

A person may also be considered a "limited purpose" public figure by having thrust themselves to the forefront of particular public controversies in order to influence the resolution of the issues involved. The determination is made on a case-by-case basis, taking the particular facts into account.

Public Figure Doctrine Law

The public figure doctrine as it relates to defamation actions had its origin in *New York Times Co. v. Sullivan*, 376 U.S. 254 (U.S. 1964). "... First Amendment requires that a public official must prove that he was libeled with malicious intent in order to recover. A finding of malicious intent requires a showing that the defendant published the defamatory article with actual knowledge of its falsity or with reckless disregard for its truth. The public figure doctrine is an attempt to strike a balance between the First Amendment interest in a press free from the self-censorship considerations arising from the existence of libel laws and the state interest in providing civil remedies for defamatory falsehood. The public figure doctrine recognizes that the state interest in protecting certain persons classed as public figures is less than in the case of purely private individuals." [Schultz v. Reader's Digest Ass'n, 468 F. Supp. 551, 555 (D. Mich. 1979)]

Robert Sylvester Kelly (born January 8, 1967)^[7] is an American singer, songwriter, record producer, and former professional basketball player. A native of [Chicago](#), Kelly began performing during the late 1980s and debuted in 1992 with the group [Public Announcement](#). In 1993, Kelly went solo with the album *12 Play*. He is known for various songs including "Bump N' Grind", "Your Body's Callin'", "I Believe I Can Fly", "Gotham City", "Ignition (Remix)", "If I Could Turn Back the Hands of Time", "The World's Greatest", "I'm a Flirt (Remix)", and the hip-hopera "Trapped in the Closet". In 1998, Kelly won three [Grammy Awards](#) for "I Believe I Can Fly".^[8] His distinctive sound and style has influenced numerous [hip hop](#) and [contemporary R&B](#) artists.

Although Kelly is primarily a singer-songwriter, he has written, produced, and [remixed](#) songs and albums for many artists. In 1996, he was nominated for a [Grammy](#) for writing [Michael Jackson](#)'s song "You Are Not Alone".^[8] In 2002 and 2004, Kelly released collaboration albums with rapper [Jay-Z](#) and has been a featured vocalist for other hip hop artists like [Nas](#), [Sean Combs](#), and [The Notorious B.I.G.](#)

Kelly is one of the best-selling music artists in the United States, with over 30 million album sales.^[9] He has released 12 solo studio albums, and sold over 75 million albums and singles worldwide, making him the most successful [R&B](#) male artist of the 1990s and one of the [best-selling music artists of all time](#).^{[10][11]} He is credited for helping redefine [R&B](#) and [hip hop](#), earning the [nicknames](#) "King of R&B" and "King of Pop-Soul".^{[12][13]} He is listed by *Billboard* as the most successful R&B/Hip Hop artist of the years 1985-2010 and the most successful R&B artist in history.^[14] He has won awards including [BET](#), [Soul Train](#), [Billboard](#), [NAACP](#), and [American Music Awards](#).

Since the 1990s, Kelly has been the subject of numerous allegations of sexual abuse and misconduct, often with underage girls, all charges he "categorically denies".^[15] In 2002 he was indicted on 13 counts of [child pornography](#).^[16] but was acquitted of all charges in 2008.^[17]

In January 2019, a widely viewed [Lifetime docuseries](#) detailed allegations of sexual abuse by multiple women, allegations Kelly denies. Facing pressure from the public using the [#MuteRKelly](#) hashtag, [RCA Records](#) dropped Kelly.^[18] On February 22, 2019, Kelly was indicted on 10 counts of aggravated criminal sexual abuse.^{[19][20]}

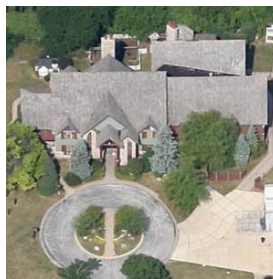
